WAIVER OF LIABILITY; ASSUMPTION OF RISK; AGREEMENT TO HOLD HARMLESS & INDEMNIFY

I desire to obtain the dog day care and/or boarding services offered by The Dog Park!.
Therefore, I hereby certify and agree as follows:

Dog's Name _____

1. I hereby represent that I am the legal owner of the dog(s) described above to be enrolled in The Dog Park!
2. I understand that I am boarding my dog in an environment where he/she may be socializing and interacting with other dogs of all sizes. As always, with the interaction of dogs, there is a chance of injury. The Dog Park! And all employees will supervise all dogs in the daycare environment but I understand that at times, due to the inherent nature of dogs, there could always be a risk that my dog may receive or give bites, puncture wounds and scrapes that may result from the playful nature of my dog as well as other dogs enrolled in the daycare program. I also understand that the benefits of the socialization and teaching far outweigh the risks. I agree to accept full responsibility, financial or otherwise, for any such injury or harm afflicted to my dog, or caused by my dog to any other dog or person while attending The Dog Park!
3. I hereby waive and release The Dog Park and its owner, employees and contractors, from any and all liability which my family, guests, designees, dog or I might sustain, including without limitation, any injury or damage resulting from the action of any such owner, employee or contractor, or from the action of any dog. I expressly assume the risk of such injury or damage while my dog and/or I, or any person accompanying me, attend any training session or other function at The Dog Park, receive any service from, or are on the premises of The Dog Park.
4. I further understand and agree that The Dog Park and their caregivers will not be liable for any problems that might develop with the dog, including, but not limited to, sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.
5. I further understand and agree that any problems that develop with my dog will be treated as deemed best and by the caregivers of The Dog Park, at their sole discretion, and that I assume full financial responsibility for any and all expense involved.
6. In consideration of, and as inducement to, the acceptance of my application for dog day care or training, I hereby agree to hold harmless The Dog Park and its owner, employees and contractors from any and all claims, suits, or damages resulting from the action of any such owner, employee or contractor, or of any dog; and I agree to indemnify The Dog Park! And its owner, employees and contractors for all claims, suits, or damages resulting from the action of me, my dog, or anyone acting on my behalf, including my family and guests.

7. I agree that the dog may be videotaped, photographed and/or recorded. The Dog Park! Shall be the exclusive owner to the results and all proceeds of such media.
8. The Dog Park! reserves the right to permanently remove a dog from its daycare at any time.
